 PROCEDURE

 1. Remove contents from box, verify if all parts listed are present and free from damage.

 Carefully read and understand all instructions before attempting installation.

 Failure to identify damage before installation could lead to a rejection of any claim.

- 2. Starting at the front mounting location on the driver's side, locate (1) Driver Support Bracket (item 8), and loosely secure the brackets using the supplied M6 hardware (items 17-20) as shown in **Figures 1 & 2**.
- 3. Repeat Step 2 for the center and rear mounting locations on the driver's side.



- 4. Locate the Driver Side Front Mounting Bracket (item 2) and loosely it to the corresponding mounting locations using the supplied M8 hardware (items 13-16). See Figures 3 & 4 for reference. <u>Note:</u> If a threaded hole is not present use the supplied M8 U-Nut Clip (Item 12) for the mounting location.
- 5. Locate the Driver Side Center & Rear Mounting Brackets (items 4 & 6) and loosely secure them to the center and rear mounting locations. See **Figures 5 7** for reference.
- 6. Repeat Steps 2 5 for the passenger side mounting locations. Note: See Figures 8 & 9 for the correct bracket orientation.

- 7. Install the Outlaw Step Bars (item 1) using the supplied M10 hardware (items 10-11). See Figure 10.
- 8. Align and adjust the steps bars as needed. Tighten and torque all hardware as specified: M6 hardware to 7-8 ft-lbs, M8 hardware to 15-18 ft-lbs, and M10 hardware to 35-38 ft-lbs.
